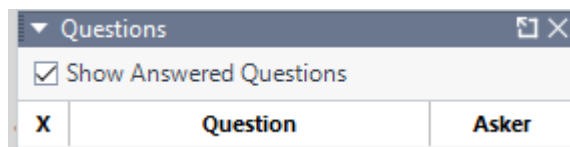

- d) **Ad hoc submission:** The analyst generates a file (structured or unstructured) and emails this to APRA. This is used for follow-up or special case collections

a) A new Data Collection Solution is central to APRA's data transformation agenda

APRA must keep pace with advances in data, analytics and technology that are redefining how individuals, organisations and governments perform their work and deliver value.

APRA's data transformation program will fundamentally change all aspects of data management.

APRA's current data collection tool D2A is nearing end of life and must be replaced.

Implementing a new Data Collection Solution will improve APRA's core data collection capabilities.

“ Our vision is to implement an easy-to-use system to collect high-quality data that is adaptable to future business needs ”

b) The new system will provide significant benefits for stakeholders



APRA has listened to stakeholder feedback calling for a data collection system requiring less manual entry and needing less duplication in data submitted.



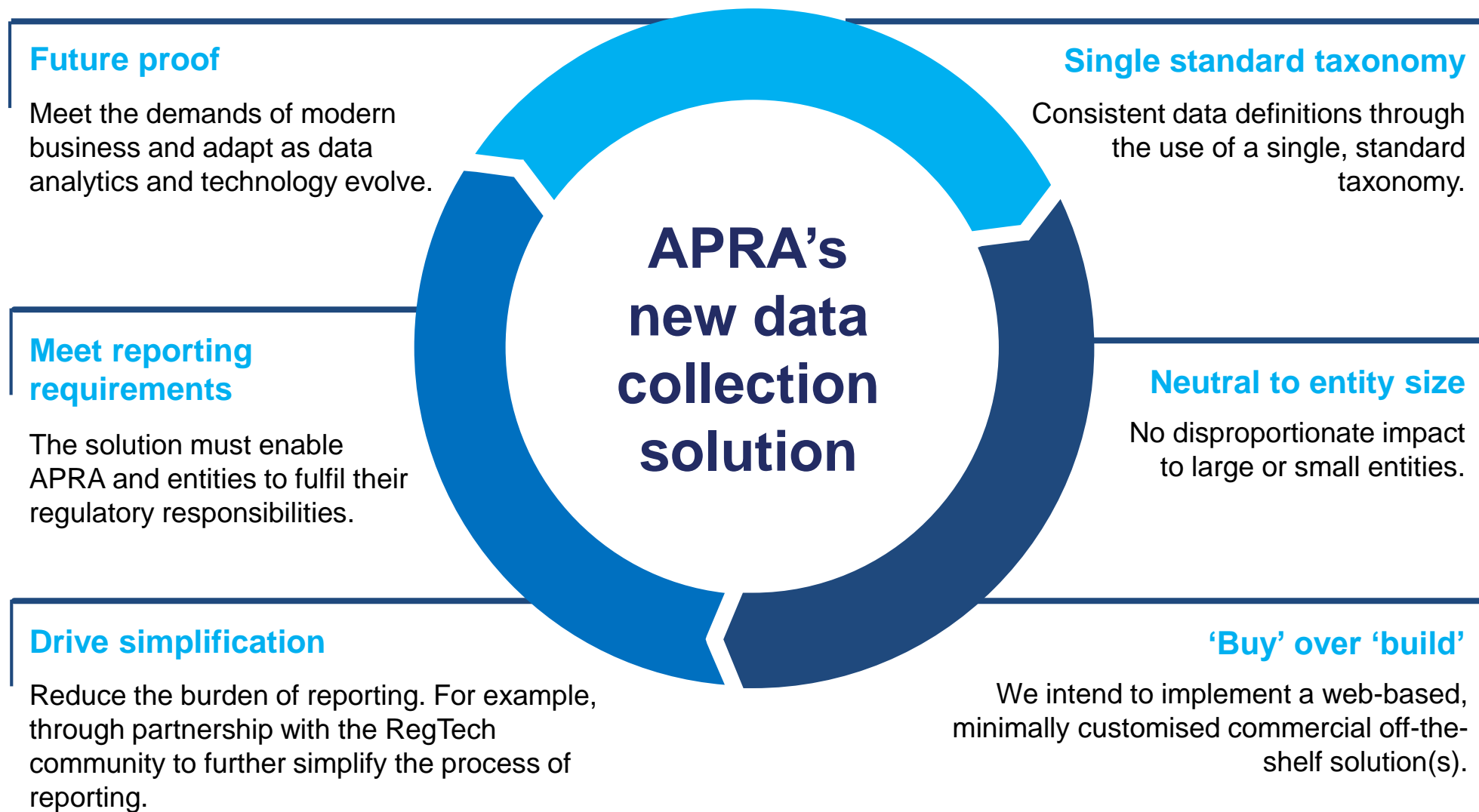
APRA anticipates that replacing D2A with a more modern and efficient Data Collection Solution will provide the following benefits to stakeholders:

- A reduction in ongoing maintenance and support costs
- Greater ease of use
- Responsive to future industry needs



APRA will work with industry to minimise the burden of implementing the new solution.

c) Key principles will guide the solution design



d) APRA is engaging with stakeholders to design and implement a new system

APRA has adopted a **new way of working with industry**. It is seeking stakeholders' advice to help design the solution and plan its implementation. Engagement is taking a variety of forms:

Responses to "Key items for stakeholder consideration"

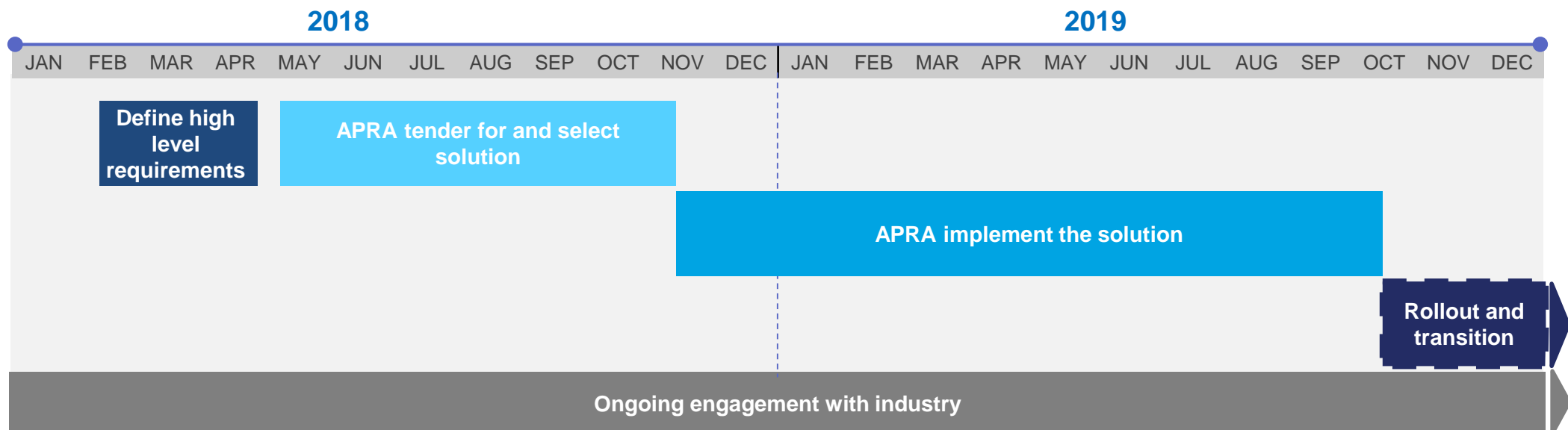


A series of webinars

APRA has developed a draft implementation timeline.



e) APRA wants to minimise the burden on industry in moving to the new system



We recognise there will be costs associated with replacing D2A with the new Data Collection Solution, and we will work with industry to minimise the overall burden

Reporting entities will have different costs

- Costs will depend on the extent of change to current systems and process that they require
- Some may also choose to invest in their internal data capabilities to maximise the benefits of the new system. APRA wants to understand these different costs and investment decisions

There will also be costs for APRA

- In line with the existing methodology, APRA's costs to implement the new solution will be covered by the Financial Institutions Supervisory Levy
- It is not yet possible to fully estimate the total cost associated with decommissioning D2A and implementing the new Data Collection Solution
