#### **1 Introduce members of the group (*Daniel Hunt*)**

Daniel Hunt welcomed members of the group and led introductions.

#### **2 Background and context of DCS and role of group (*Daniel Hunt*)**

Daniel Hunt provided context on the role of the group. The key goal at these meetings is to have high-level discussions with a broad forum to understand and find resolutions to technology-related issues related to the implementation of, and transition to, the new solution.

#### **3 Discuss and confirm terms of reference (*Daniel Hunt*)**

The terms of reference (ToR) were endorsed. It was confirmed APRA has the expectation members of the group will share and provide information from these meetings more broadly with industry.

#### **4 Data Collection Solution (*Rosemary Nyul*)**

APRA provided a preview of the key components of the upcoming DCS response to industry. The TWG members provided feedback on these points.



#### **5a API integration (*Gurvijay Bhatti*)**

APRA shared their plans for providing API Integration capability. The TWG discussed that the API capability should be developed in stages and members indicated they would be prepared to co-design the capability working alongside APRA.

#### **5b Testing (*Paramita Verghese*)**

APRA shared its early thinking around the usage of the external testing environment, specifically around the multi-purpose nature of the environment. It was agreed that the TWG would work collaboratively with APRA in developing test scenarios.
